GSS Security Personnel Duties & Responsibilities

GSS Guards carry out the following functions at individual premises:

The Security Guard on duty should be well dressed, report in time and take over the duty from the previous guard with all details and messages.

The Security Guard on duty is responsible for safe guarding the clients premises and should maintain the following registers and records:-



(a) **Staff attendance registers**



(b) **Material IN/OUT registers**



(c) **Vehicle movement register**



(d) **Visitor pass and register**



(e) **Guard's diary**

The Security Guard should frisk all male workers at the time of leaving the premises and check their baggage and lunch box as directed by the client.

He should ensure that NO materials is brought IN or taken OUT without proper document. The outgoing Dc's should carry the authorized person signature. A list of personnel authorized to sign the Dc's along with specimen signature should be kept in the security office.

The Security Guard will screen all incoming visitors and issue visitor pass in consultation with the Admin authorities (optional).

The Security Guard should ensure that there is no unwanted public movement in front of main gate.

He should ensure that a security round of the premises is carried out hourly intervals in silent hours (22.00 hrs to 06.00 hrs)

The Security Guard should make sure that no company property is damaged in any form. He should maintain cordial relation with the management and liaison with admin authorities on day to day basis.

Note: Above quoted points are general guidelines for the Security Guard to perform his duties effectively and efficiently. However he should take proper directives from the person concerned for smooth functioning of security system.
